

Complementary and Alternative Health Care Client Bill of Rights

On July 1, 2001, Minnesota Statutes, Chapter 146A took effect. This law requires us to post this *Client Bill of Rights* in a prominent location, and provide each “complementary and alternative health care client” a written copy of this *Client Bill of Rights* prior to providing services.

This law also requires that you sign a written statement, prior to service, attesting that you received this *Client Bill of Rights*.

Under Minnesota law, an unlicensed complementary and alternative health care practitioner may not provide a medical diagnosis or recommend discontinuance of medically prescribed treatments. If a client desires a diagnosis from a licensed physician, chiropractor, or acupuncture practitioner, or services from a physician, chiropractor, nurse, osteopath, physical therapist, dietician, nutritionist, acupuncture practitioner, athletic trainer, or any other type of health care provider, the client may seek such services at any time.

Assessment and Recommended Service – You have the right to complete and current information concerning our practitioner’s assessment and recommended service to be provided, including the expected duration of the service.

Treatment Rights – You have the right to:

- Expect courteous service, and
- Be free from verbal, physical, or sexual abuse by your practitioner,
- Clients will not be denied services based on race, religion, sexual orientation, age, and/or handicapping conditions.

Please be aware that:

- Other complementary and alternative health care services may be available in the Community – information on such other services can be found in the yellow pages.
- You have the right to choose freely among available practitioners and to change Practitioners after services have begun.

Confidentiality – Your records and transactions with us are confidential, unless release of these records is authorized in writing by you, or otherwise by law.

Access to Records and Information – You have the right to be allowed access to records and written information from records in accordance with Minnesota Statutes, Chapter 144.335.

Right to Refuse Treatment – As the client, you may refuse services or treatment, unless otherwise provided by law,

No Retaliation – You may assert your rights without retaliation.

Complaints – As client, you have the right to file a complaint. To do so, just call or write the supervisor to file your complaint. You may also file any complaint by contacting:
